ELIGIBILITY CRITERIA FOR REPUTE CONTRACTORS: Having successfully completed One *Similar work* of value not less than 80% of the Estimated Tendered value. OR Two Similar works of value not less than 60% of the Estimated Tendered value. OR Three Similar works of value not less than 40% of the Estimated Tendered value. *All amounts rounded off to a convenient full figure, in the last 7years ending on the last day of the month previous to the one in which the tenders are invited.*

SIMILAR WORK: means having carried out work of similar scope/natures i.e. :-

For work at Sr.No.1:- The Repair or maintenance of Swimming Pool Plant at any Government Department/Autonomous Bodies/Private Sector & Should submit guarantee bond towards waterproofing of Swimming Pool for 5Years upon successful completion of work.

INSTRUCTIONS TO BIDDER/APPLICANT/CONTRACTOR

- The successful Bidder/Applicant/Contractor has to obtain Contract Labor License from the office of Labor Commissioner Goa.
- The bid's/Application of those Bidder/Applicant/Contractor with more than four works in hand (with SAG) will be rejected as per Circular No.SAG/EE-ED/Circular/F.17/T-Adm/2016-17/659; Dt:18/05/2016.
- The Bidder/Applicant/Contractor or his Representative may attend the opening of tenders.
- The Bidder/Applicant/Contractor should upload the scanned declaration giving names of the works in hand.
- The successful Bidder/Applicant/Contractor is bound to obtain necessary Permissions/N.O.C. for the respective works from the relevant Departments, as per CPWD/PWD procedures, before starting the work in consultation with SAG.
- Any addition/deletion/correction in the Tender Documents CORRIGENDUM will be published only on the (www.tsag.org) SAG's website and on the (www.tenderwizard.com/GOA) Website only.
- The intending Bidder/Applicant/Contractor must agree to terms and conditions of CPWD Form 6 & Form 8. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for Bidder/Applicant/Contractor posted on website shall form part of bid document.
- Bidder/Applicant/Contractor must ensure to quote rate of each item. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) & will be treated as incomplete tender.
