MINIMUM ELIGIBILITY CRITERIA FOR REPUTE CONTRACTORS: Having successfully completed One *Similar work* of value not less than 80% of the Estimated Tendered value. OR Two Similar works of value not less than 60% of the Estimated Tendered value. OR Three Similar works of value not less than 40% of the Estimated Tendered value. *All amounts rounded off to a convenient full figure, in the last 7 years ending on the last day of the month previous to the one in which the tenders are invited.*

SIMILAR WORK : means having carried out work of similar scope/natures i.e. :-

For work at Sr.No.2:- The Repair or maintenance of Swimming Pool Plant at any Government Department/Autonomous Bodies/Private Sector.

The successful Bidder/Applicant/Contractor is bound to obtain necessary Permissions/N.O.C. for the respective works from the relevant Departments, as per CPWD/PWD procedures, before starting the work in consultation with SAG.

The intending bidder must agree to terms and conditions of CPWD Form 6 & Form 8. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

Information and Instructions for bidders posted on website shall form part of bid document.

Bidder must ensure to quote rate of each item.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) & will be treated as incomplete tender.
